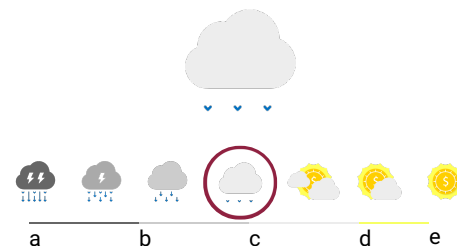

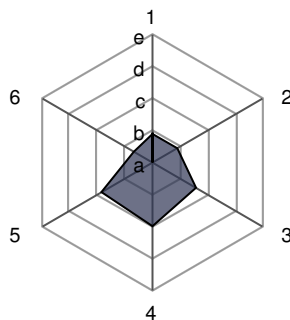

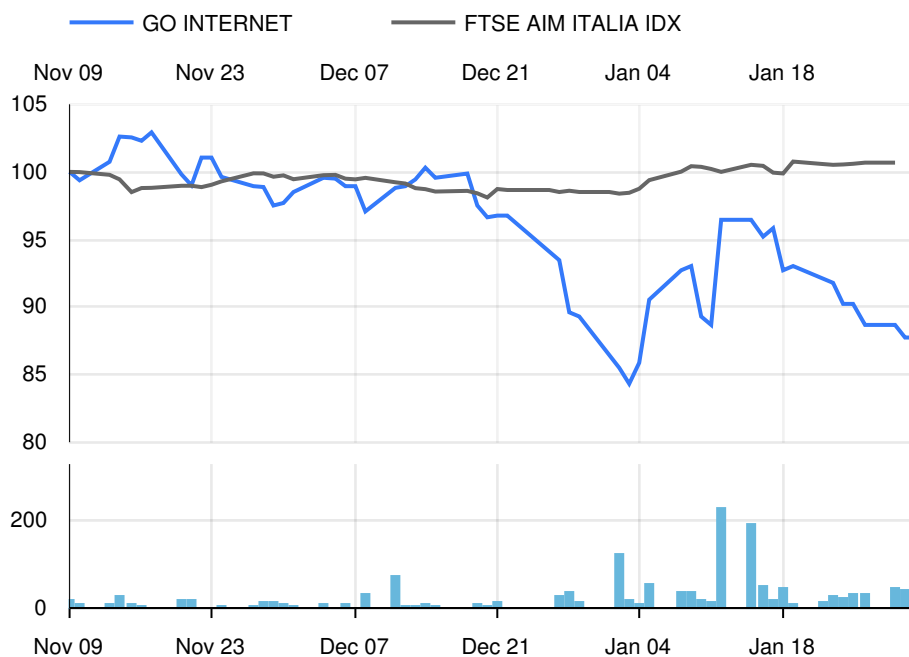

Last week return (in percentage). The higher the 1W RTN value, the higher the return of the last week. A small value of this indicator means that the return is negative. A value of 0.5 indicated that the stock price is unchanged and the return of the last week is 0

2.1 Y RTN

Last year return (in percentage). The higher the 1Y RTN value, the higher the return of the last year. A small value of this indicator means that return is negative. A value of 0.5 indicated that the stock price is unchanged and the return of the last year is 0.

3. UPSIDE

Indicates how large is the expected stock rise. The higher the Upside value, the higher the stock rise. A value of 0.5 indicates a 15% expected rise within a month thereafter.

4. PROB UPSIDE

Indicates how large is the probability that there will be a stock rise. The higher the ProbUpside value, the stronger is the probability that the stock rises.

5. VAR

Refers to the estimated maximum loss that a financial instrument can record in one day with a given probability level. This measure is observed statistically and corresponds to the 5th percentile of daily yield distribution (VAR95). VAR is reported on RADAR on scale 0-1 and with an inverse representation where a "wide" radar corresponds to a lower risk, while a "narrow" radar corresponds to a greater risk.

6. CURRENT VOLATILITY

Indicates the level of the price fluctuations of the last week. A higher indicator value indicates that a security's value can potentially be spread out over a larger value. A stock with a volatility of 0.5 is expected to move 50% for every move in the benchmark.

RSI:

The Relative Strength Index (RSI) is a momentum indicator, that compares the magnitude of recent gains and losses over a specified time period to measure speed and change of price movements of a security. RSI values of 70 or above indicate that a security is becoming overbought or over-evaluated and therefore may be primed for a trend of reverse or corrective pullback in price. RSI values of 30 or below are commonly interpreted as indicating an oversold or under-evaluated condition.

MACD:

Moving Average Convergence Divergence (MACD) is a trend-following momentum indicator that shows the relationship between two moving averages of prices. A MACD above 0 indicates an upward momentum. Below 0, a downward momentum.

R-cluster:

R-cluster is an indicator which categorizes stocks in 5 risk clusters. High stock-cluster value represents stocks with the high volatility.
